### PARADE GUIDELINES AND RULES

1. Entries must pertain to the holiday and the Christmas theme, "Winter Wonderland",
2. This is an evening parade; therefore, CHRISTMAS LIGHTS ARE REQUIRED. (Minimum of 100 lights).
3. All entries should be decorated to the "This Little Light of Mine" Christmas theme please.
4. Please No Santa's or Mrs. Claus. (There is only 1 Santa and he has his own entry).
5. For the safety of spectators and parade participants, all animals must be accompanied by a chaperone.
6. You may register if needed, at the staging area registration booth.
7. We must have your Completed "announcement" (the accurate and clear description of your entry/business/organization) section.
8. No Alcohol or political messages allowed with any of the Parade entrants. All entries will be subject to parade staff approval.
9. Entrants may hand out candy, but only by a walker from your entry. No throwing of candy or other items is permitted.
10. Please arrive with your float/vehicle/group no later than 6:00 p.m. to avoid congestion and to assure your entry in the parade.
11. Please note that drop off/pick up and parking, for float Entrants/Participants will be in the **East parking area** directly across from the El Paso County Fair Grounds.
12. Facemask use will be determined by the current State status and guidelines on requirements per CDC. (Have masks if required)
